REEPRING POLIC

Whereas, **Di- Tech Engineers** and PCPS Girls' Polytechnic have the area of common interest in Education and training (for the students of Diploma in Computer Engineering Department and social activities, considerable advantage may be gained from their pursuit on a collaborative basis in the field of education and training.

Now therefore **Di-Tech Engineers** and PCPS Girls' Polytechnic have decided to enter into this Memorandum of understanding (hereafter referred to as MOU), which defines the framework for the cooperation of the two organizations set out in the following sections.

- 1. The first party shall arrange the training programs for the students of **Civil Engineering** at its own organization to the group of 4 to 10 students of the second party during the Term-end vacations of the last two Terms of the Diploma course considering of 15 days per term. On successful completion of the Training programme the first party shall issue certificate to the participating students of the second party duly signed by the authority.
- 2. The first party shall depute experts on demand, time to time as visiting faculty to the second party against agreed terms and conditions.
- 3. The second party shall extend full assistance on demand from the first party with the help of its faculty members/staff in trouble shooting, drawing, estimating, surveying etc if necessary.
- 4. The first party shall provide support to the second party in curriculum redevelopment if necessary.
- 5. Both parties shall make provisions to share their respect research and development (R&D) facilities in order to promote academic and research interaction in the area of cooperation.
- 6. This MOU is executed in duplicate with each copy being an official version and having equal legal validity initially for a period of 1 (one) year and renewable each year (12 months).
